"I am honored to receive this recognition because it highlights the importance that women-owned businesses have in strengthening the US economy," said Hay. "LMT's success is evidence that women-owned businesses can not only survive but can thrive in today's global marketplace. They are a vital part of the U.S. economy."

This recognition comes on the heels of Lanmark Technology, Inc.'s recent win of a full and open competitively bid half billion dollar IDIQ contract supporting the Department of Defense. Ms. Hay credits LMT's growth and success to working in partnership with the Small Business Administration and American Express OPEN, more specifically the SBA 8(a) Small Business Development Program and the American Express OPEN Make Mine a Million \$ Business Program. Regarding the SBA 8(a) Program, Ms. Hay worked hand in hand with the SBA to learn how to compete for federal contracts as a small business, with the intent of graduating after completing the 9 year program ready and prepared to compete for federal contracts in the full and open competitive arena. Regarding Ms. Hay's experience with American Express, after being turned down for credit by two major credit cards when LMT first opened for business, American Express extended credit to LMT which helped facilitate its growth to a million dollar company within two years. Additionally, the Make Mine a Million \$ Business program provides women business owners with the money, marketing and mentoring needed to break the million-dollar revenue barrier.

"Support for small businesses is a non-partisan issue. Small Businesses are the backbone of America and will lead the country out of the current economic downturn. My success story is what the SBA under several administrations has facilitated, and American Express has supported. It is my hope that this recognition serves as inspiration for the next generation of entrepreneurs and business owners.
